\*(\_\_\_) **Booking fee/deposit:** In the event of the Clients canceling the session or Rescheduling to an unavailable date for whatever reason. The booking fee is non-refundable. If rescheduling is required your booking fee will be held for rescheduling time if there is an additional cancellation your booking fee will be forfeit & will be considered as liquidated damages to the Photographers The booking fee is due on signing this agreement (Booking Fee is 20% of “Total amount agreed plus any fees required for use of studio or shooting space ” (booking fee = \_\_\_\_\_) Initial when deposit paid (\_\_\_\_) with the balance of the total amount \$\_\_\_\_\_ due \_\_\_/\_\_\_/\_\_\_ no less than 14 days before the day of the event additional fee of 20% of the total quote will be added to the remainder owed for any event where the balance is paid less than 14 days from the event.

**Entire Agreement:** This agreement contains the entire understanding between the Clients and the Photographer. Any changes made must have initials of clients and photographers.

**Confirmation:** A signed “Contract for Wedding Photography Services” and payment of the booking fee are necessary to reserve the date for the stated wedding services from the Photographers.

**Pre-Wedding Consultation:** This normally happens at the time of booking. The Clients will outline broadly what is required and the Photographer will advise on planning, logistics and timings where needed. If required the Clients are welcome to pop in for an additional chat closer to the time of the wedding (about 2 weeks) to iron out the remaining details. In any case we will contact you by phone a few days before the wedding to ensure that there have been no last minute changes.

\*(\_\_\_) **Cooperation:** The Clients and the Photographer consent to cooperating and communicating with each other to achieve the best possible result within the understanding of this contract. We recommend that the Photographer be provided with a helper (usually the best person) who will point out key individuals to be photographed. The Photographer may also require the assistance of the best person in organizing family groups. The Clients also agree to give the Photographer sufficient warning of key events at the wedding to give the Photographer time to prepare e.g. Bouquet throwing, cutting the cake, speeches etc. Please note that not all guests at weddings like having their photo taken. In such cases the Photographer will use his discretion but cannot be held responsible for a lack of photos of these people. Any person involved in sexual harassment or otherwise inappropriate treatment of our staff will be warned once and the Coordinator will immediately be notified if the behavior continues all photography services will be stopped and no funds will be returned.

The Schedule: Our shooting schedule, style of working and experience are designed to achieve a great set of wedding photos for the Clients, accomplished with good humor and enjoyed by all concerned. Both the Clients and the Photographers therefore agree that punctuality and cooperation are essential to producing outstanding photographic results. In cases where the wedding does not run on time (for example, extreme lateness by one of the Clients arriving to the church) we cannot guarantee to take our normal set of photos although in such circumstances we will do our absolute best to compensate. Please check with your other vendors to ensure that yours is the only wedding they have.

\*(\_\_\_) **Posed photo time allocation:** A minimum of 1 hour should be allocated before the reception with the wedding party and immediate family for posed photos, possibly more depending on the number in your party. This happens once, let us capture it the way you want to remember it. Failure to allocate this time will result in a lack of posed photos in the final product.

**Paparazzi Wedding Guests:** All your guests will have digital cameras and all your guests will want to photograph the Clients. In the spirit of cheerful cooperation the Clients agree to give the Photographers precedence over the guests in order to take the photographs required for the wedding services described above. We cannot be held liable for a lack of wedding photos if guests taking their own photos of the Clients continually interrupting the Photographer's work. If given the choice please smile at the big

expensive camera instead of the iPhone.

**House Rules:** Note the Photographers are sometimes limited by rules imposed by registrars, ministers and venue management as to what can and cannot be done. For example some ministers insist that no flash photography is allowed, and others will insist that the Photographers shoot from a specific location. In such circumstances the Clients agree to accept the technical limitations that may be imposed on the equipment used. We advise the Clients to make themselves aware of the rules of the venue concerned and if necessary negotiate with the personnel concerned.

**Copyright Law:** The copyright of photographs remains with the Photographer. The Photographer grants the Clients permission to print and make copies of the images under the following conditions. First, that the images taken by the Photographer are for any non commercial use by the Clients and their friends and relatives. Second, that sale, publication or any Commercial use of the photographs is not allowed without prior written permission from the Photographer.

**Complementary engagement shoot:** weather and schedule permitting, a complimentary engagement Photo shoot will be offered select images from this shoot will be delivered via digital gallery upon the completion of this contract and a paid booking fee.

**Appearance:** Please be aware that the photographer and equipment will visually capture as much as possible and you may be photographed with clothing or accessories that you were unaware of, i.e. a hair tie around your wrist or sunglasses on your head. In short if you don't want to see an item in the final product, don't wear it for the picture. You may want to task your maid of honor and best man as wardrobe police.

\*()**Model Release:** The Clients grant the Photographer(s) and its legal representatives, heirs and assigns, the irrevocable and unlimited consent to use the photographs of the Clients for editorial, competition, advertising and any other purpose and in any manner, to alter the photographs without restriction; and to copyright the images. The Clients hereby release the Photographer and its legal representatives, heirs and assigns from all liability and claims in connection with the images. This is required except in the case of boudoir shoots (  ), (  )

**Limit of Liability:** If a photographer is ill or becomes injured and cannot supply the wedding services specified above the Photographer will try to book a replacement photographer of equal skill. Under normal circumstances a second photographer is there for the day anyway and this photographer will then shoot the day on his/her own. If both photographers are unavailable and a replacement photographer cannot be found then liability is limited to a refund of any payments received. The Photographers have working methods in place to prevent loss or damage to your images. However, there is the unlikely possibility that images may be lost, stolen or destroyed for reasons in or beyond our control. In these circumstances liability is limited to the return of fees paid for the service or part thereof according to the percentage of images supplied.

\*()**Travel Expense:** If the travel time from Hyde park NY to your wedding location exceeds 30 min travel time then travel will be charged at 1/2 of our hourly rate. Lodging is based on the available rates.

**Products & Services:** digital files of the photographers selection are included with the aforementioned fee. Some digital retouch will be done to select files. Additional editing is available and will be done at a rate of \$60 per hour or \$20 per photo whichever is greater.

\*()**Videography:** In an effort to maintain a high standard, the photographers require that our videographers are employed for any paid video recordings made of your event, and that no other media recording vendors are used.

**Delivery:** digital files will normally be delivered via gallery within 6-10 weeks final edits will be delivered via usb drive this time allows for quality digital retouch. If you would like to see the editing in progress you may contact us via social media and you will receive updates as they are completed. Additional photo products are subject to vendor wait time in on top of aforementioned editing time.

**Weather:** Although rain on ones wedding day is said to be good luck, our equipment does not hold up in the rain for extended periods of time. It is therefore up to the photographers discretion how we will handle potential outdoor photos in the rain.

\*() **Image Archival:** The photographers will keep your RAW images on file for 6 months from the date of the wedding, so that you may request additional services and or products sourced from the original images, example: photo albums, prints, more in depth editing. There will be a \$25 fee for each month after 6 months this fee will be added to any order placed after the 6 month archival has passed. These additional products or services may come at additional expense.

**Other vendors and contracts:** It is understood that no other vendor's contract signed by the client shall supersede this agreement. The client is under no circumstances permitted to promise usage rights of Erin Braden Photography's work to other vendors. If contracted by a vendor in regards to permitted usage or expected copies of photographic material including digital files; the client must inform Erin Braden Photography as well as provide the requester Erin Braden Photography's contact information. At no point should the client provide any vendor with digital or print files without prior written consent from Erin Braden Photography. If a client is in breech of this section they will be held liable for the fees associated with commercial use of each individual image used by the vendor at a rate of no less than \$500 per photo. **inform**

**Booking Fee/Deposit:** In the event of the Clients canceling the wedding or Rescheduling the wedding to an unavailable date for whatever reason. The booking fee is non-refundable, It will be considered as liquidated damages to the Photographers. a single date reschedule is allowed after that another booking fee will need to be paid.
